**Explanation**

Engineers in Action (EIA) provided funding and managed in-country (Bolivia) personnel, including 5 engineers, a water technician, and 2 part-time accountants. EIA builds partnerships to facilitate local community-identified needs in remote Bolivian villages. Projects in 2013 were primarily providing potable water to villages using various technologies such as collecting and transporting water from springs, hand-pumps for shallow wells, and deep drilled submersible pumps with water tanks; depending upon the location. In addition we had projects dealing with acid-mine drainage, erosion control, irrigation, sanitation and electrification. Our PRIMARY partners are: Engineers Without Borders (EWB); Rotary Clubs in Bolivia, US and Canada; various Bolivian NGO's; and various Bolivian Municipal (county) governments. We have numerous additional smaller partnerships. Summary of accomplishments in 2013 include: We are now reaching over 90,000 people with some form of self-determined engineering infrastructure need; In additional, we had 3 teams come for Assessment trips: EWB-Florida Univ. to Aripalca, EWB-Arizona-Marquirivi, EWB-Virginia Commonwealth-San Antonio Lomerio; and 8 additional Implementation teams come: EWB-Tulsa Univ - Cotani; EWB- S&T - Los Eucalyptos; EWB-S&T - Tacachia; St. Paul's United Methodist Church to Konani; EWB-VMI -Pampoyo; EWB-Univ of Calif at Davis- Quincucirca; EWB-Colorado Springs Professionals - Sorata; EWB-Dresden Germany - Zamora; and recruited 3 more teams to come in 2014: EWB-Cornell-Calcha; EWB-Minnesota Univ-Yulo; EWB-St. Louis Professionals - Tarija; we also continued the Chiquitano Safe Water Project where we now have repaired and are maintaining over 300 hand pumps serving over 50,000 people. Highlighted Project for 2013: The Juckucha River has been dead for over 100 years from acid-mine drainage from abandoned and active mines with a ph equal to that of battery acid, yet is still used for agricultural use downstream leaving very high levels of Cadmium, Lead and Arsenic in the blood of those living along the river. In 2013 we completed the hand installation of 4 million lbs. of limestone in two 1.5km channels located at over 15,000' in altitude. The river has started to return to life surprisingly fast with grass, moss, algae and even birds returning to the valley. Our major partners are: The universities of Oklahoma, St. Francis Univ in Pennsylvania, and Tomas Frias University in Potosi Bolivia, Rotary Clubs in Potosi, Norman Oklahoma and elsewhere; The Departmental (State) Government of Potosi; and many smaller players.
